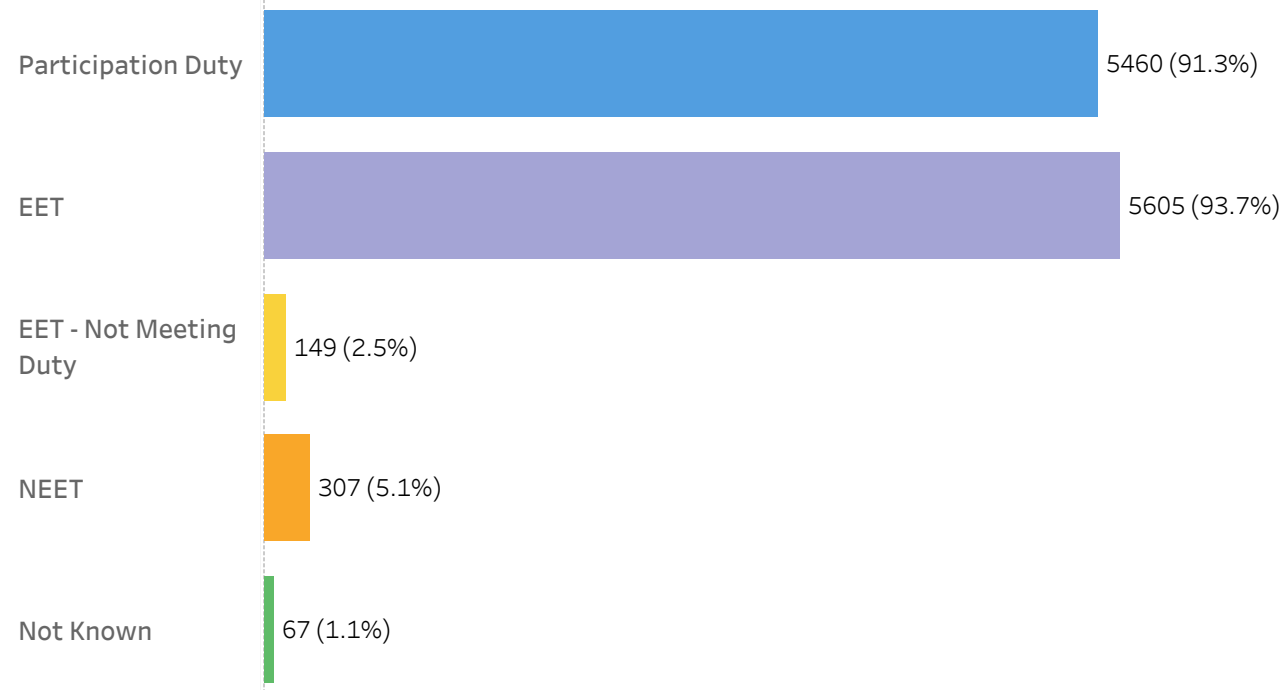

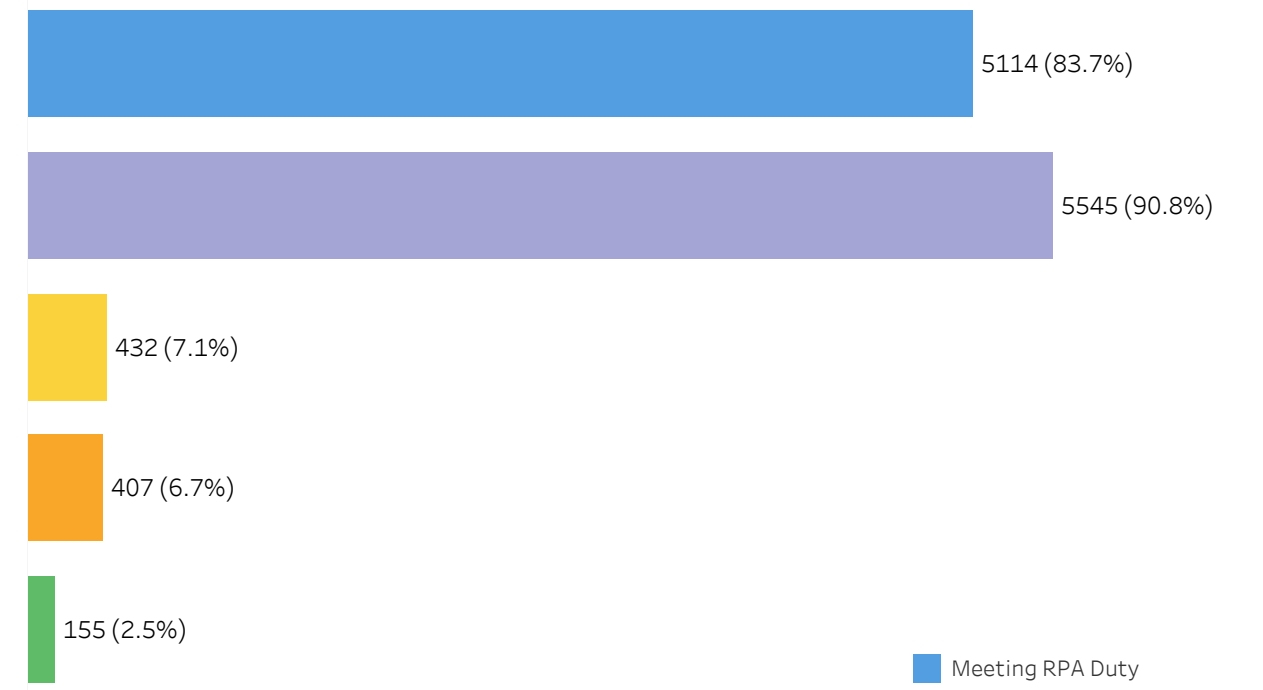

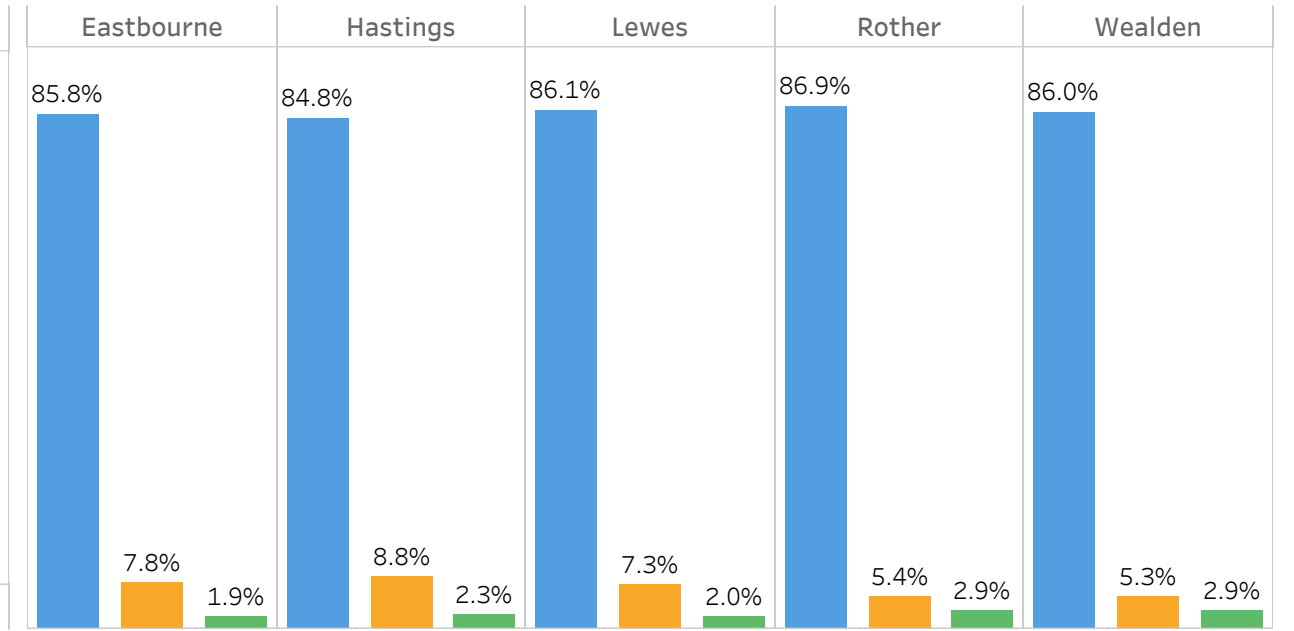

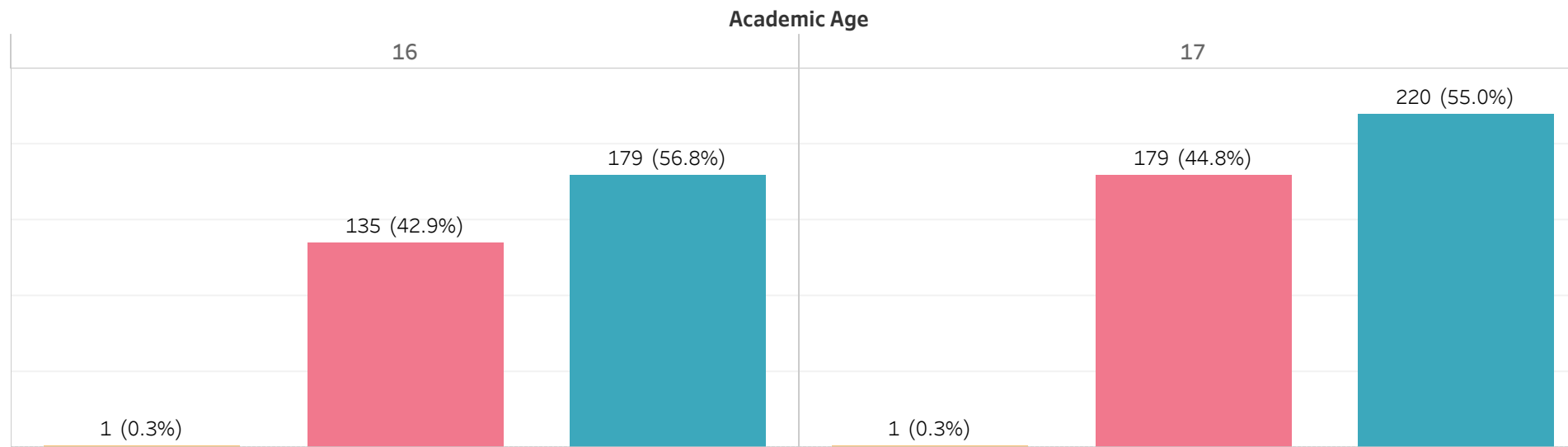

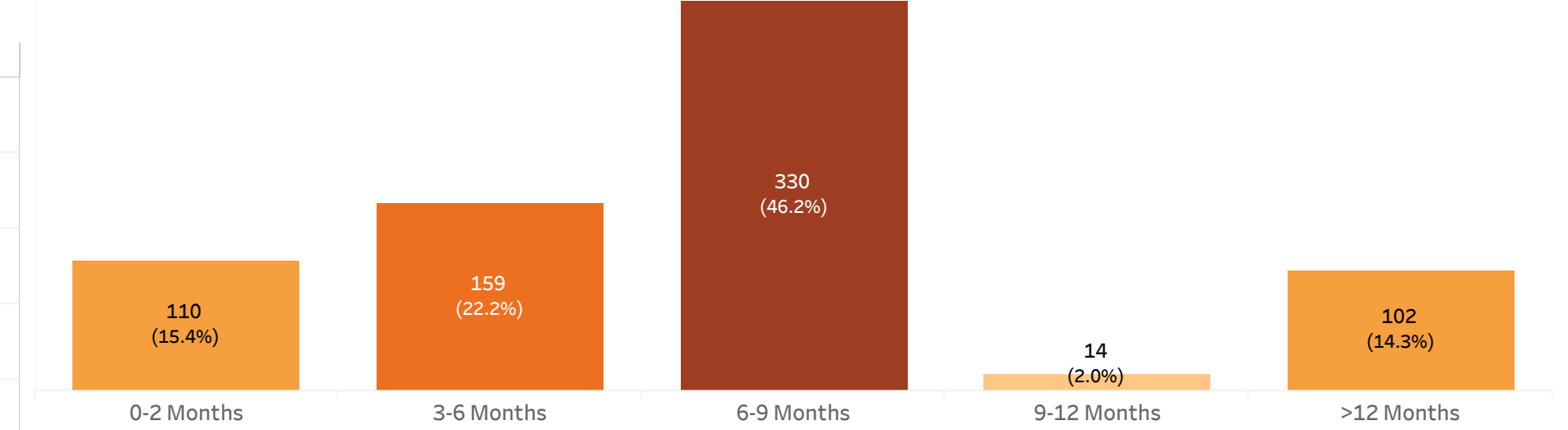

(with % of year group NEET)

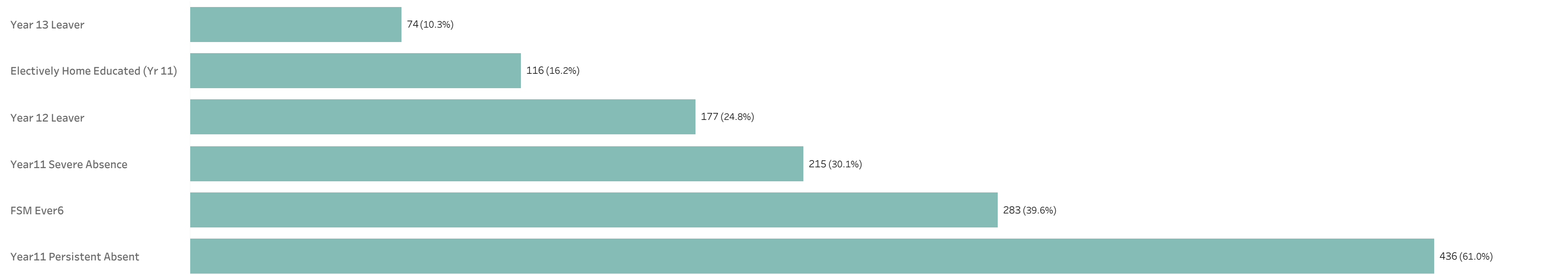


NEET Durations

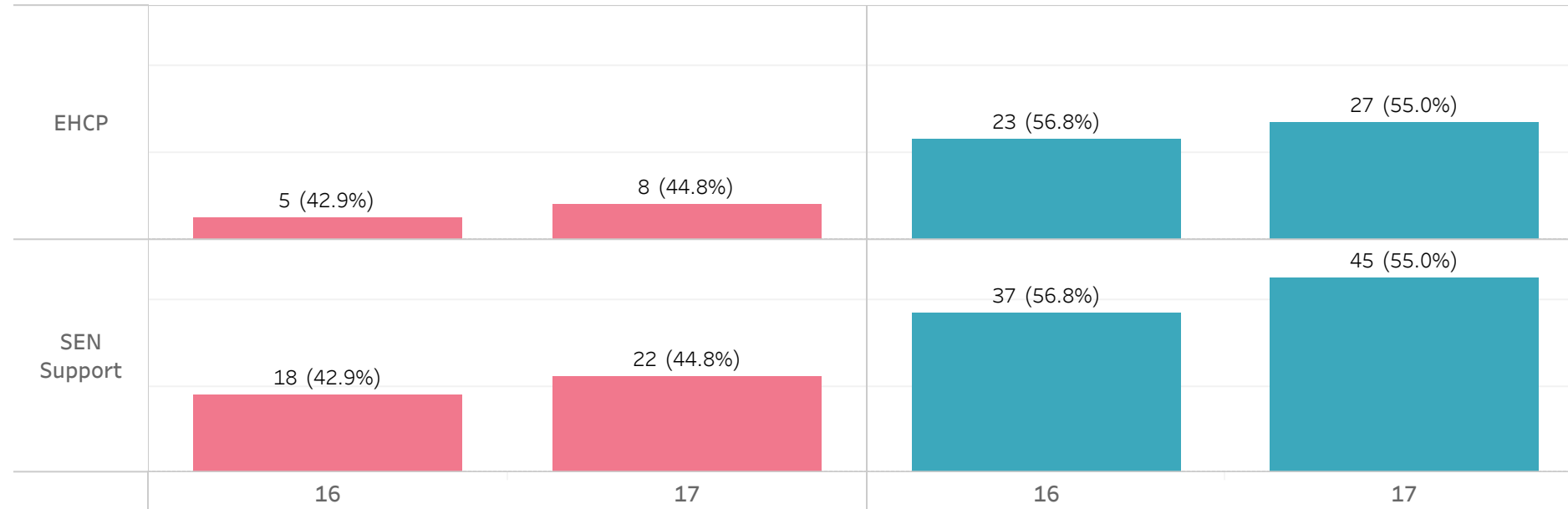

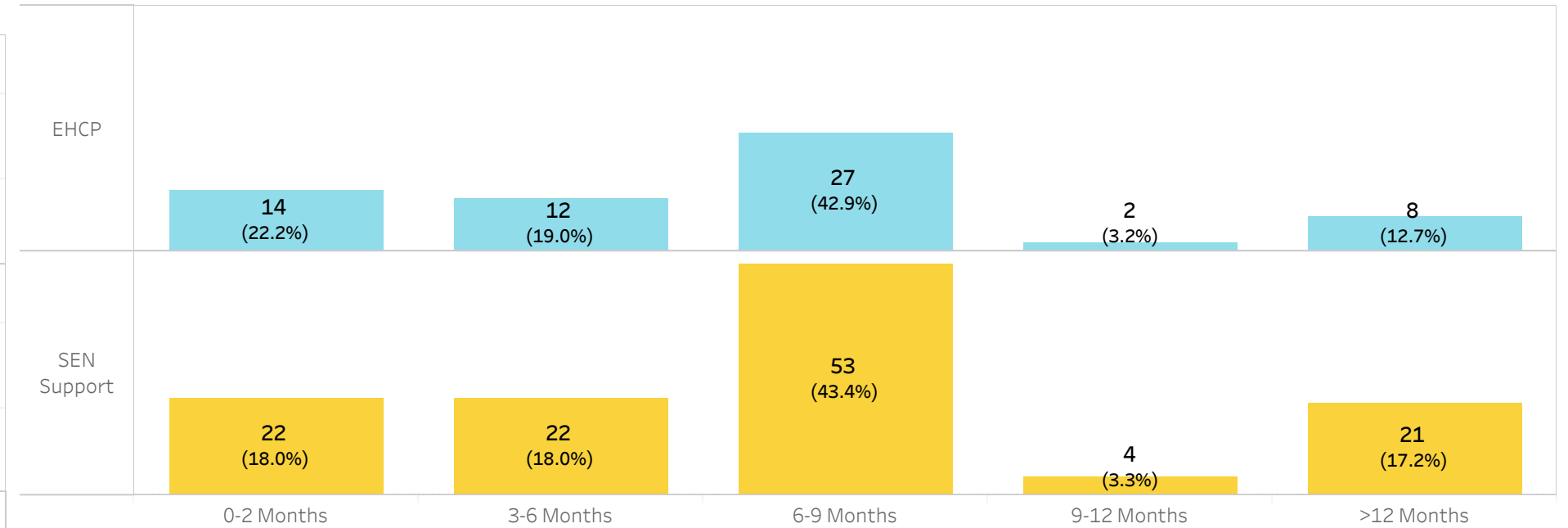

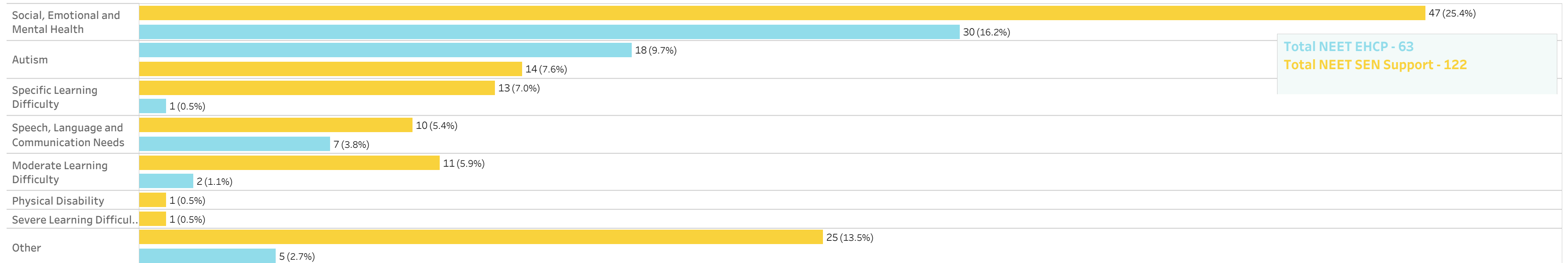
SEND NEETs per Year Group, Sex and Academic Age (with % of year group NEET)



SEND NEET Durations



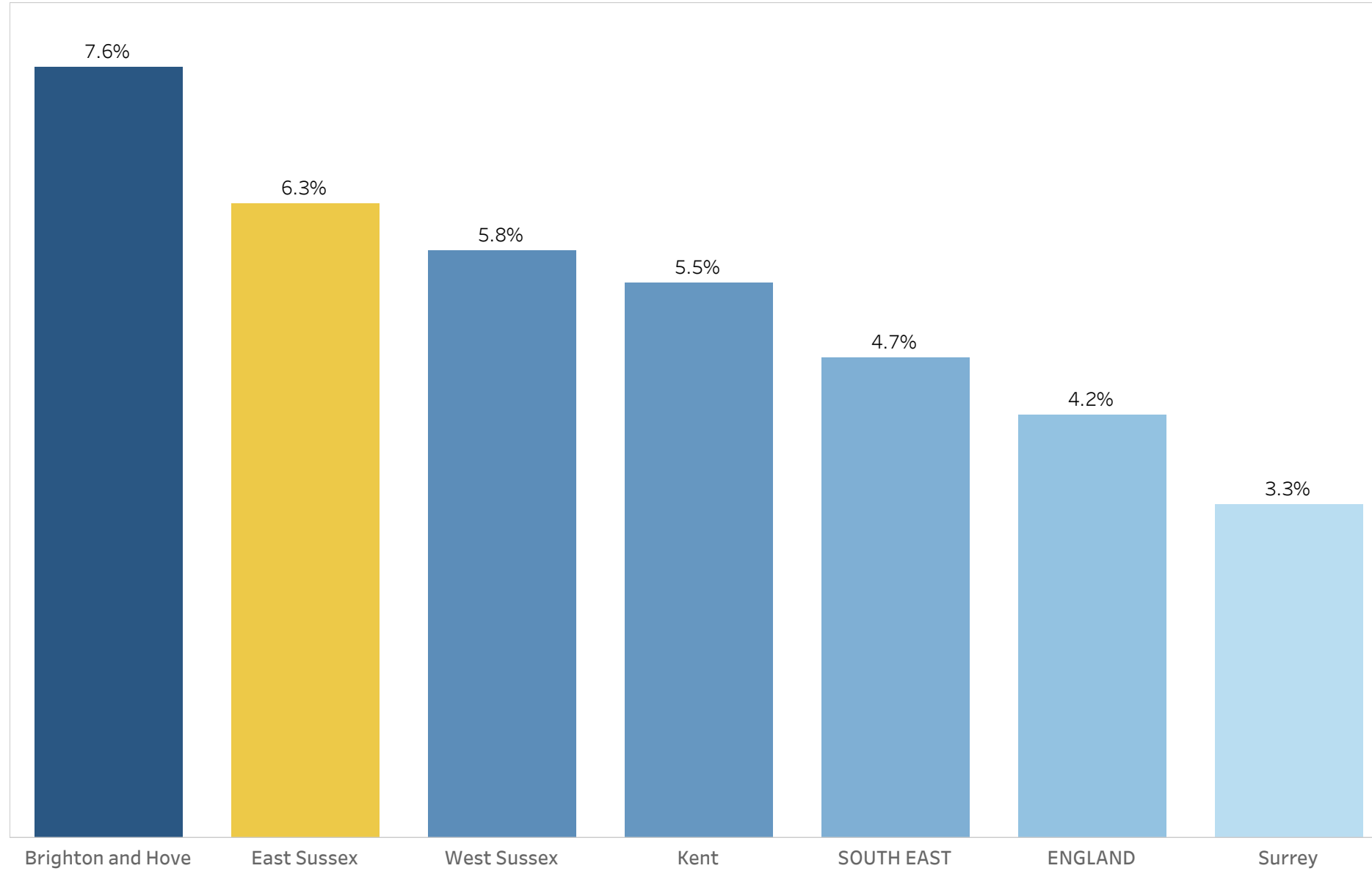
NEET Primary Need by SEND



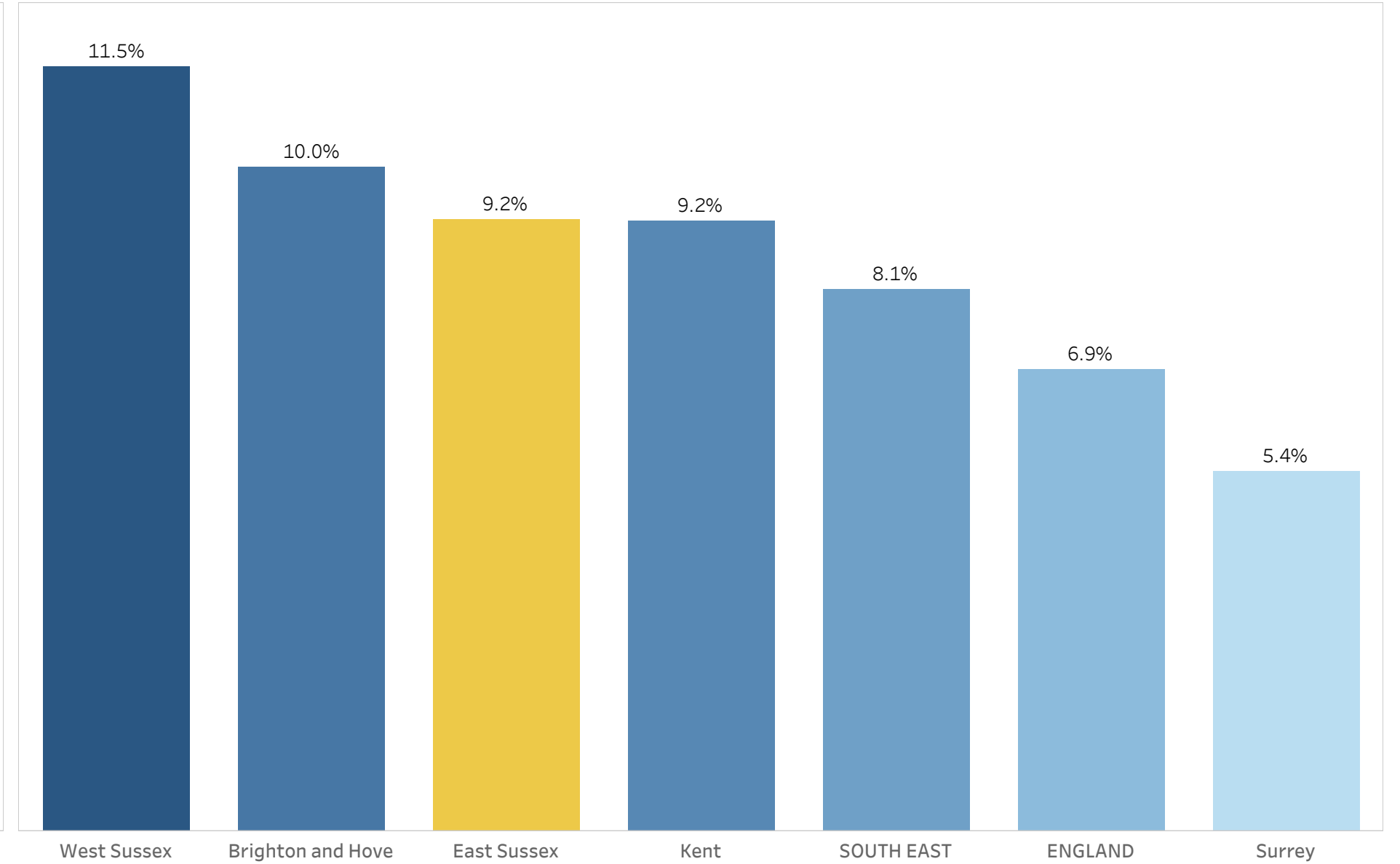

SEN Support

A learner with a learning difficulty or disability which calls for special educational provision to be made for them, but whose needs do not meet the criteria for an EHC plan.

EHCP

A learner with an Education Health and Care Plan

SEN Support is recorded by schools during Year 11 and remains on a learner record throughout Year 12 and 13

An EHCP Flag remains on a learner record throughout Year 12 and 13

Mental Health & Emotional Wellbeing Flag:

This is down to the discretion of the YES advisor working with the young person

Year 11 Persistent Absence:

Absence of 10% or more during Year 11.

Year 11 Severe Absence:

Absence of 50% or more during Year 11.
